TO: THE NINTH CIRCUIT OF APPEALS

My name is Patricia A. Levy, I am a resident of Riverside and Orange Counties, I am over 18 years old, and I do not suffer from any mental impairment, I have personal knowledge of the following events and declare under penalty of perjury that:

I have been following the ineligibility lawsuits against Barack Obama for the last 2 years. At first I was apprehensive as to the charges, but after reading for many hours the claims made against him, I came to the conclusion that something has to be done to uphold our constitution.

Last summer I attended three hearings in Santa Ana at the Ronald Reagan Court House. The judge that was presiding was Judge David Carter. At the first hearing there were only about 35 attendees. Dr. Taitz stated her charges and the fact that she had been stonewalled on every suit that she has filed without the courts ever hearing the case on its merits. The U.S. attorneys, of course, wanted the case to be dismissed. Dr. Taitz pled with the court to hear the merits of her case and allow for discovery, since all of Obama's records have been either sealed or destroyed. Despite the objection of the U.S. attorneys, Judge Carter made it clear that he would hear the merits of the case because if Obama was a legitimate president he needed to have this cloud removed, and if he isn't legitimate he needs to be removed from office. I inquired as to why this was necessary and I was told the U. S. Marshall wanted the information. I felt like it was a form of intimidation. I was in the main court When Judge Carter entered the courtroom, he was like a different man. He was very subdued and not at all as he had appeared at the previous two hearings. During the hearing he admonished Dr. Taitz for something she had done and he would not let her even respond to his admonishment. Needless to say, I and everyone around me were astounded by the change in the judge. At the end of the hearing Judge Carter stated that he would respond to the motions at a later date.


