MOTION FOR RECONSIDERATION DUE TO NEW INFORMATION

Dr. Orly Taitz, ESQ, petitioner herein, is submitting this motion for reconsideration, demanding reconsideration of placement of the name of a candidate Barack Hussein Obama (hereinafter "Obama") on the ballot or alternatively nullification of any and all votes for him due to the fact that candidate Obama is not eligible to the office of the President of the United States of America and the Commander in Chief of the U.S. military. This motion is brought due to

new information showing Obama using a computer generated forgery instead of a valid birth certificate.

ARGUMENT

1. According to Article 2, Section 1 of the US Constitution President of the United States needs to be a natural born U.S. citizen.

2. Primary documents of attestation and verification of a natural born US citizen status are a Long Form Birth certificate and a Social Security card.

3. On November 18, 2011 Petitioner herein brought a challenge before this commission, attesting to the fact that Barack Hussein Obama is not a natural born citizen and he is using a computer generated forgery, that he posted on WhiteHouse.gov, as a proof of his natural born citizen status. He is, also, using a stolen Social Security number issued in the state of Connecticut to an individual born in 1890 in the state of Connecticut. She also submitted evidence, showing that the name that Obama is using, is not legally his.

4. During the commission hearing the chair of the commission, Mr. Brad Cook inquired, whether Petitioner has an opinion of any authority, confirming such assertions. At a time there was no governmental authority confirming evidence produced by Taitz.

5. On March 1, 2012 sheriff Joe Arpaio released results of a 6 month investigation. His conclusion confirmed evidence produced by Taitz. Press Release and video links of Arpaio investigation are included with this appeal as an exhibit 1.

6. Sheriff Arpaio's investigation concluded that Obama's long form birth certificate is indeed a computer generated forgery, consisting of layers of bits and pieces imported from other documents. Most troubling is the fact that the stamp of the registrar and the date stamp were imported from other documents.

7. Additionally Sheriff Arpaio noted that the data of the immigration and naturalization service relating to the week of August 1 and August 7 1961 is missing from the National Archives, while such data is present for other dates for the same year, which suggests that someone has tampered with the records of the National Archives and removed the data relating to the international travel of

Stanley Ann Dunham, Barack Obama's mother which can be incriminating to Obama.

8. Additionally Taitz is resubmitting court transcripts and case file from the Administrative court in Georgia, where during the January 26, 2012 hearing Taitz submitted into evidence sworn testimony of a number of witnesses attesting to the same findings. Among them:

- a. Testimony of John Sampson, Senior deportation officer of the Department of Homeland Security with 30 years of experience attesting to signs of forgery in Obama's birth certificate and Social Security number and testifying that in cases like this he would usually seek warrant for an arrest and deportation.
- b. Testimony of an investigator with 20 years of experience testifying to fraud in Obama's Social Security records.
- c. Testimony and attestation, showing that in the passport records of Obama's mother, Stanley Ann Dunham, he was listed under the name Soebarkah
- d. Several other testimonies relating to forgery and fraud in Obama's records.

Certified copies of the transcript and case file from Georgia Administrative court as well as certified copies of the records by Sheriff Arpaio will be provided upon request.

9. During the November 18, 2011 meeting of the Ballot Law Commission Mr. Cook claimed that the ballot law commission does not investigate eligibility of the candidates. This statement was not true.

10. Minutes of prior hearings of the Ballot Law commission and records of the office of the Secretary of State of New Hampshire showed that on multiple prior occasions the Ballot Law Commission and the office of the Secretary of State routinely removed from the ballot individuals, whose records showed them not to be eligible for office they sought.

11. If in light of the additional evidence the ballot law commission and Secretary of State of New Hampshire do not nullify the votes for Mr. Obama, all five members of the ballot law commission, Deputy Secretary of State and Secretary of State will become complicit in elections fraud, uttering of forged documents and in High Treason against the State of New Hampshire and against the United States of America. Petitioner would like to remind Mr. Bill Gardner, Secretary of State of New Hampshire, Mr. David Scanlan, Deputy Secretary of State of New Hampshire, and each and every member of the Ballot Law Commission, that the penalty for High Treason is life in prison or death penalty.

CONCLUSION

Due to all of the above information Obama's name needs to be stricken from the ballot. Any and all vote cast for Obama need to be held invalid and nullified. Secretary of State of New Hampshire and Ballot Law Commission need to forward to the District Attorney of the Merrimack County and Attorney General of New Hampshire all of the information provided herein for criminal prosecution of Obama and his accomplices.
