Re: Violation of ER 4.1 (a) and submitting fraudulent information to the Court.

Dear Bar Prosecutor,

In connection with the case Taitz v Elections Commission case NO:49D141203MI12046 filed in the Supreme Court of Indiana the client of attorney Michele L. Forney (hereinafter Forney) was served with subpoena requesting to provide information about his knowledge of Barack Hussein Obama (hereinafter Obama) forged identification documents. In a letter to presiding Judge Reid, attorney Forney stated that her client Secretary of State Ken Bennett does not have any evidence showing that there is fraud and forgery in Obama's identification papers. In addition, not only attorney Forney wrote this fraudulent statement, she tried to intimidate and harass me as a whistleblower.

In reality Ken Bennett received letters from twelve hundred constituents who forwarded to him copies of the press release and transcript of press conference by Sheriff Joe Arpaio, Maricopa County, Arizona, that showed that Obama is using a forged birth certificate, forged selective service certificate, and fraudulently obtained Social Security number. Later, the only thing Ken Bennett received from Hawaii Department of Health was the letter from Alvin T. Onaka, the same individual who is suspected of being a part of a group of individuals in

the Health Department in Hawaii complicit in this forgery. Ken Bennett never received the original birth certificate. Moreover, two detectives from Maricopa County Sheriff's Department flew to Hawaii, requested examination of Obama's birth certificate and were denied access to inspect the original birth certificate that supposedly on file.

Both Ken Bennett and Assistant Attorney General of Arizona Forney have all of this information and they defrauded Judge Reid and attorney Forney violated Rule 4.1 (a) of the Code of Professional Conduct. Moreover, both Bennett and Assistant Attorney General Forney continue to defraud the public, and for those reasons I demand full investigation and sanctions against attorney Forney who sent this letter with fraudulent information to Judge Reid in the Superior Court of Indiana presiding in the case Taitz v Elections Commission.
