the SS # 423-29-2961 issued to Clay D Land on March 24th 1960 at the address of 1313 Tulakes Dr. Columbas, Ga 31904 but used by Obama at the address of 505 Farr Apt. C Columbas, Ga ( a low income , government subsidized, privately owned apartment complex, owned by Farrfield Manor ?)

The original documents on file and in handwriting show that the agent is "Clay Land", but signed by Shannon Land


