

DECLARATION OF DR. ORLY TAITZ, ESQ

I, Orly Taitz, am a licensed attorney in the state of California and I am admitted in the 9th Circuit Court of Appeals, 3rd Circuit Court of Appeals and the Supreme Court of the United States

1. I obtained attached affidavits showing that Barack Hussein Obama is fraudulently using a Connecticut Social Security number xxx-xx-4425, which according to Social Security e-verify system was never assigned to him, which is a clear evidence of Social Security Fraud.
2. I personally entered above Social Security number on the www.sss.org Selective Service verification systems with name Obama and date of birth August 4, 1961 and got a response “match”, showing that Barack Obama is indeed using in his official records social security number, that was never assigned to him.
3. After Mr. Obama posted on WhiteHouse.gov his alleged true and correct copy of his original birth certificate, certified by Director of Health Loretta Fuddy, I obtained multiple expert affidavits, contained herein, showing that the document in question is not and cannot be a true and correct copy of any paper document, but rather a computer generated composite, consisting of bits and pieces of different documents with different typesetting and partially filled in with computer generated graphics.

4. As an officer of the court and concerned with the fact that the U.S. national security is undermined, I repeatedly wrote to the director of Health Loretta Fuddy, advising her of my finding.
5. I served Loretta Fuddy with attached subpoena, seeking inspection of the original birth certificate.
6. I served Ms. Fuddy both through her attorney Deputy Attorney General Nagamine and directly at the Health Department.
7. I repeatedly called and e-mailed Ms. Nagamine, seeking an answer, whether her client Ms. Fuddy will comply on August 8, 2011. Ms. Nagamine did not respond.
8. I sent a Federal Express letter, received by Mr. Fuddy on July 28th, where I asked her to respond, whether she will comply with the subpoena and advised her, that it will cost me thousands of dollars to travel from mainland together with two experts. Ms. Fuddy did not respond.
9. Ms. Fuddy or her attorney Ms. Nagamine never filed an opposition to subpoena nor a motion to quash the subpoena. Defendant in the case Commissioner of the Social Security administration Michael Astrue or his attorney, assistant U.S. attorney Patrick Nemeroff never filed an opposition to subpoena, never filed any motion to quash the subpoena, therefore Ms. Fuddy was obligated to comply on August 8, 2011.
10. My two experts and I arrived at the Health Department of Hawaii, at 1250 Punchbowl ave, Honolulu, HI at 10 AM August 8, 2011. Ms. Fuddy was not available. I was given a letter, written the same day by

Ms. Nagamine, stating that Ms. Fuddy will not comply with the subpoena. Such letter did not constitute proper and valid opposition to subpoena.

11. As of now due to actions of Director of Health Loretta Fuddy there is a most egregious breach of the U.S. national security and the whole nation is kept hostage by an individual occupying the position of the president and commander in chief of the U.S military, while lacking a valid Social Security number and with a computer generated composite instead of a valid birth certificate.

The President believed the distraction over his birth certificate wasn't good for the country. It may have been good politics and good TV, but it was bad for the American people and distracting from the many challenges we face as a country. Therefore, the President directed his counsel to review the legal authority for seeking access to the long form certificate and to request on that basis that the Hawaii State Department of Health make an exception to release a copy of his long form birth certificate. They granted that exception in part because of the tremendous volume of requests they had been getting. [President Obama: 'I wanted a long form birth certificate with the seal from DHS.'](#)

President Barack Obama wanted to move past the [birth](#) certificate controversy he called "silliness" when he released the long-form document a few months ago. But now his own party is using the birth certificate to raise money.

The Democratic National Committee (DNC) is pitching potential donors with envelopes stamped: "HELP US COUNTER THE GOP'S DIRTY TRICKS," CBS News [reported](#). Inside, the alert reads: "ENCLOSED: President Barack Obama's Birth Certificate." The mailer includes a copy of Obama's official Hawaii "Certificate of Live Birth." Those who donate at least \$44 get a [coffee mug](#) imprinted with Obama's birth certificate.

The DNC did not immediately respond to The Daily Caller's request for comment on why Democrats are using the issue Obama decried to raise money or who at the DNC initiated and approved such fundraising measures.


As you know, several years ago, my client requested a certified copy of his birth certificate and received, pursuant to the policy and practice of the Hawaii Department of Health, a Certification of Live Birth, sometimes referred to as a "short-form" or abbreviated birth certificate. This Certification of Live Birth is, of course, legally sufficient evidence of birth in the State of Hawaii. Moreover, it is my understanding that it is, and has been, the Department of Health's longstanding policy and practice to provide only the "short-form" version when a certified copy of a birth certificate is requested.

We understand that the Department of Health has adopted this policy for sound administrative reasons. However, we are writing to request a waiver of the Department of Health's policy, so that my client can obtain two certified copies of his original, "long form" birth certificate. Waiver of the Department's policy in this instance would allow my client to make a certified copy of his original birth certificate publicly available and would also relieve the burden currently being placed on the Department of Health by the numerous inquiries it receives from the media and others relating to my client's birth record.

We are of course, willing to complete any necessary paperwork and pay the standard required fees to fulfill this request. Pursuant to my client's authorization, I will be coming to your offices to pick up the copies of the certificates.
