## DECLARATION OF DR. ORLY TAITZ, ESQ.

- I, Orly Taitz, am a licensed attorney in the state of California and I am admitted in the 9<sup>th</sup> Circuit Court of Appeals, 3<sup>rd</sup> Circuit Court of Appeals and the Supreme Court of the United States
  - I obtained attached affidavits showing that Barack Hussein Obama is fraudulently using a Connecticut Social Security number xxx-xx-4425, which according to Social Security e-verify system was never assigned to him, which is a clear evidence of Social Security Fraud.
  - 2. I personally entered above Social Security number on the www.sss.org Selective Service verification systems with name Obama and date of birth August 4, 1961 and got a response "match", showing that Barack Obama is indeed using in his official records social security number, that was never assigned to him.
  - 3. After Mr. Obama posted on WhiteHouse.gov his alleged true and correct copy of his original birth certificate, certified by Director of Health Loretta Fuddy, I obtained multiple expert affidavits, contained herein, showing that the document in question is not and cannot be a true and correct copy of any paper document, but rather a computer generated composite, consisting of bits and pieces of different documents with different typesetting and partially filled in with computer generated graphics.

- 8. I sent a Federal Express letter, received by Mr. Fuddy on July 28<sup>th</sup>, where I asked her to respond, whether she will comply with the subpoena and advised her, that it will cost me thousands of dollars to travel from mainland together with two experts. Ms. Fuddy did not respond.
- 9. Ms. Fuddy or her attorney Ms. Nagamine never filed an opposition to subpoena nor a motion to quash the subpoena. Defendant in the case Commissioner of the Social Security administration Michael Astrue or his attorney, assistant U.S. attorney Patrick Nemeroff never filed an opposition to subpoena, never filed any motion to quash the subpoena, therefore Ms. Fuddy was obligated to comply on August 8, 2011.

In 2008, in response to media inquiries, the President's campaign requested his birth certificate from the state of Hawaii. The state sent the campaign the President's birth certificate, the same legal documentation provided to all Hawaiians as proof of birth in state, and the campaign immediately posted it on the internet.

When any citizen born in Hawaii requests their birth certificate, they receive exactly what the President received. In fact, the document posted on the campaign website is what Hawaiians use to get a driver's license from the state and the document recognized by the Federal Government and the courts for all legal purposes. That's because it is the birth certificate. This is not and should not be an open question.

The President believed the distraction over his birth certificate wasn't good for the country. It may have been good politics and good TV, but it was bad for the American people and distracting from the many challenges we face as a country. Therefore, the President directed his counsel to review the legal authority for seeking access to the long form certificate and to request on that basis that the Hawaii State Department of Health make an exception to release a copy of his long form birth certificate. They granted that exception in part because of the tremendous volume of requests they had been getting.

Waiver of the Department's policy in this instance would allow my client to make a certified copy of his original birth certificate publicly available and would also relieve the burden currently being placed on the Department of Health by the numerous inquiries it receives from the media and others relating to my client's birth record.

We are of course, willing to complete any necessary paperwork and pay the standard required fees to fulfill this request. Pursuant to my client's authorization, I will be coming to your offices to pick up the copies of the certificates.
