## A LETTER FROM GERMANY

Ladies and Gentlemen,

My name is Felix Deutschmann. On November 4, 1994 I emigrated from Moscow to the German Federal State of Thuringia. Some time later, Germany witnessed the event that not only made severe changes in all my life and in the lives of my closest friends and relatives; moreover, it created a real threat to the safety of the Jews living in Germany.

On September 1, 2001 The Bild - a leading German newspaper - reported about that with traditional German meticulosity; ironically, it had happened 10 days before the terrorists from Hamburg branch of Al-Quaeda attacked New York.

The Bild's journalists got personal access to the secret documents and wrote about the criminal activity in the Thuringian office of Versfassungsschutz, including the transfer of German Jews' personal data to the Iranian terrorists. The private data were transferred by Thomas Dienel, a Verfassungsschutz agent (also known as Küche). And it was Dr. Helmuth Roewer, the President of the Thuringian Verfassungsschutz office, who was behind Dienel's actions.

But Dr. Richard Dewes, the Thuringian *Innenminister*, prohibited to investigate Roewer's law-breaking activity.

Karl-Heinz Gasser, the *Staatssekretär* of the Thuringian Ministry of Justice, investigated the activity of the Verfassungsschutz and its ex-President Dr. Helmuth Roewer. In his secret report he caught Dr. Roewer and the people under him in having broken the criminal law: "First of all, it was about Dienel's malicious contacts with the Iranian Embassy in Bonn. Despite it all, the Verfassungsschutz supported him firmly…"

In his report Mr Gasser recommended not to prosecute anybody.

In 2011, a National Socialist underground group (Nationalsozialistischer Untergrund or NSU) was disclosed. It turned out that the group's members - Uwe Mundlos, Uwe Böhnhardt and Beate Zschäpe - had committed 10 murders, including that of Michel Kiesewetter, a Thuringian-born female police officer (who was on duty at that moment). She was shot to death in Heilbronn on April 25, 2007. Then her male colleague was also shot in the head but survived.

The NSU group couldn't have committed their crimes without the support of professional secret agents. Not having been organized, supported and financed by the Thuringian Verfassungschutz office, they'd have been unable to commit them.

The collaboration between Dr. Helmuth Roewer, the former President of the Thuringian Verfassungsschutz office, and Iranian terrorists put the US national safety at risk. It's widely known that the stolen personal data can be used to produce fake passports. And the fake passports can be used to enter the American territory. The German Jews' personal data got by the Iranians can be a perfect legend to work undercover.

Dr. Helmuth Roewer was questioned by the Special Bundestag Committee on Feb 21, 2013 - but only to get the evidence for the case of Mundlos, Böhnhardt and Zschäpe.

It's obvious that only Beate Zschäpe will be punished (as the only alive member of the group), but the organizers and supporters will remain free. The personal data theft case will also remain unsolved.

I think it is really necessary to investigate what lies behind the information published by the Bild - that it was Dr. Helmut Roewer, the ex-President of the Thuringian Verfassungsschutz office, who stood behind German Jews' personal data theft and the murders. I'm also convinced that it will be helpful for the investigation of the series of murders committed by the NSU cell members

It looks obvious that relying on German legal bodies and waiting for fair investigation of these crimes would be naive.

Dr. Helmuth Roewer is a key figure both in the data theft case and in creating and protecting of the neo-Nazi terrorist underground group (or NSU, as it's called now). That's why investigating his crimes is potentially helpful in finding the Iranian agents who can enter (or could have entered) the US territory using the stolen personal data.

I ask you to find an American lawyer who could assist me in investigation of the case in question.

I have a fund to pay for legal assistance.
