#### SUPPLEMENTAL BRIEF WITH NEWLY DISCOVERED INFORMATION

Supplemental brief provides following newly discovered information:

I. NEWLY DISCOVERED INFORMATION SHOWING THAT CUSTODIAN OF RECORDS OF DEFENDANT OBAMA, OCCIDENTAL COLLEGE HAS PREVIOUSLY RELEASED OBAMA'S COLLEGE APPLICATION TO THE MEDIA AND TO THE PUBLIC, AS SUCH AFOREMENTIONED RECORD WAS NOT SEALED, HAD TO BE RELEASED AND THE COURT ERRED IN DENYING A MOTION SEEKING TO COMPEL THE RELEASE OF THE RECORD AND AWARDING THE ATTORNEYS FEES TO THE CUSTODIAN OF RECORDS.

II. ACCORDING TO LAURIE HATTAWAY, EMPLOYEE OF THE HESC (HIGHER EDUCATION SERVICES CORPORATION), AFTER OBAMA TRANSFERRED FROM OCCIDENTAL COLLEGE TO COLUMBIA UNIVERSITY, HE RECEIVED FINANCIAL AID AS A FOREING STUDENT, CITIZEN OF INDONESIA, WHICH SHOWS OBAMA MOST PROBABLY ATTENDED OCCIDENTAL COLLEGE AS A FOREIGN STUDENT AND OCCIDENTAL WAS COVERING THIS FACT IN ORDER TO AID AND ABET DEFENDANT OBAMA IN ILLEGALLY GAINING U.S. PRESIDENCY.

III. DEFENDANT OBAMA IS IMPROPERLY USING THE MEANS OF THE U.S.
GOVERNMENT, SPECIFICALLY FBI, IN ORDER TO HARASS, BULLY AND
INTIMIDATE WHISTLEBLOWERS WHO ARE BRINGING FORWARD INFORMATION
SHOWING HIM BEING A CITIZEN OF INDONESIA AND ILLEGALY USURPING THE
US PRESIDENCY.

RECORDS OF DEFENDANT OBAMA, OCCIDENTAL COLLEGE HAS PREVIOUSLY RELEASED OBAMA'S COLLEGE APPLICATION TO THE MEDIA AND TO THE PUBLIC, AS SUCH AFOREMENTIONED RECORD WAS NOT SEALED, HAD TO BE RELEASED AND THE COURT ERRED IN DENYING A MOTION SEEKING TO COMPEL THE RELEASE OF THE RECORD AND AWARDING THE ATTORNEYS FEES TO THE CUSTODIAN OF RECORDS.

1. Appellant submits an affidavit and attached DVDs as Exhibit 1 Transcript and DVDs were received by e and represent a true and correct copy of the FOX-TV interview of Jim Tranquada, Director of Communications of the Occidental college as posted on you-tube, on the Internet under title "Obama's real history", part 2 http://www.youtube.com/watch?v=XHZPDS\_ITAQ.

Affidavit of Terrence Brennan was signed and notarized on September 9, 2013 and was received by the Appellant on September 11, 2013. This material was not available to the appellant earlier.

Attached affidavit verifies authenticity of a transcript of a TV show by Bill Hemmer, reporter for FOX news corporation, which was posted on You-Tube. During the show Bill Hemmer interviewed Jim Tranquada, Director of Communications of Occidental college, who not only showed the reporter the dorm where Barack Obama resided, but he also showed him Barack Obama's college application. The reporter posted on the screen a picture of Barack Obama, which was attached to his Occidental College application.

00:00 Narrator: Obama left behind Hawaii, for college, in Southern California.

(Photo of envelope stamped "CARDED ON CONDITION THAT THE HOLDER REMAINS IN----NO LONGER THAN STAY)

00:05 Narrator: Here is the photo of the eighteen year old, attached to his Occidental college application.

Legal challenge at hand relates to elections challenge of Barack Obama in light of his Indonesian citizenship and in light of governmental records and expert affidavits showing Obama using computer generated forgeries instead of genuine IDs. Additionally appellant, who is a registered California voter and who was a candidate for office on the ballot, challenged one and a half million invalid voter registrations.

Appeal was filed for two reasons:

- a. Lower court erred and abused its judicial discretion in dismissing the appeal
- b. Lower court erred and abused its judicial discretion in denying Taitz motion to compel production of redacted student records of Barack Obama from Occidental College for the purpose of revealing Obama's citizenship on his application and registration. This was essential, as Obama was registered as an Indonesian citizen in his school records in Indonesia, was removed from his mother's US passport due to his Indonesian citizenship and Obama's school registration at Occidental

college was an essential factor to show that he confirmed his Indonesian citizenship while at college after the age of majority and therefore is not constitutionally eligible to serve as the US President. Obama was served with pleadings repeatedly and did not show up. Custodian of record, Occidental college argued that the records are sealed and opposed the motion to compel release of aforementioned records. Plaintiff argued that Obama's citizenship is not a private matter, Obama already revealed his alleged citizenship by claiming that at all times he was the U.S. citizen, therefore requested record would not be a private matter and in the interest of National security, legitimacy of the U.S. Presidency outweighs any considerations of privacy, even if those considerations existed. Lower court ruled in favor of the custodian of records.

Attached DVD of the interview given by Jim Tranquada, Director of Communications of the Occidental college, show that the records were not sealed, that he freely gave FOX News reporter Obama's application to the Occidental college and allowed to show on National TV and the Internet the photograph of 18 year old Obama, which was attached to the aforementioned application. As such Judge Marginis ruled in favor of the Occidental college on the basis of information, which was not true.

Provided information is admissible, was not available at the time the Appellants' brief was filed and helps the fact finder to rule on the appeal.

2. ACCORDING TO LAURIE HATTAWAY, EMPLOYEE OF THE HESC (HIGHER EDUCATION SERVICES CORPORATION), AFTER OBAMA TRANSFERRED FROM OCCIDENTAL COLLEGE TO COLUMBIA UNIVERSITY, HE RECEIVED FINANCIAL AID AS A FOREIGN STUDENT, CITIZEN OF INDONESIA, WHICH SHOWS OBAMA MOST PROBABLY ATTENDED OCCIDENTAL COLLEGE AS A FOREIGN STUDENT AND OCCIDENTAL WAS COVERING THIS FACT IN ORDER TO AID AND ABET DEFENDANT OBAMA IN ILLEGALLY GAINING U.S. PRESIDENCY.

Please, see exhibit 2, affidavit of Orly Taitz. This information is relevant, as Obama's citizenship at Occidental college was at issue.

Further, when Taitz called Hathaway for a follow up, she was told that currently FBI is investigating Hathaway due to her release of Obama's Indonesian citizenship information. This is relevant, as currently there is a pattern of intimidation of whistle blowers who come forward with information of fraud committed by Obama.

3. DEFENDANT OBAMA IS IMPROPERLY USING THE MEANS OF THE U.S.
GOVERNMENT, SPECIFICALLY FBI, IN ORDER TO HARASS, BULLY AND
INTIMIDATE WHISTLEBLOWERS, WHO ARE BRINGING FORWARD INFORMATION
SHOWING HIM BEING A CITIZEN OF INDONESIA AND ILLEGALY USURPING THE
US PRESIDENCY.

As stated, Whistleblower Hathaway is currently being investigated by the FBI.

On 09.16.2013 Taitz received a sworn declaration (Exhibit 3) from yet another whistle-blower, researcher, debt collector and skip trace investigator Albert Hendershot, disclosing that he was visited by the FBI after he released information showing that Barack Obama is using a Connecticut Social Security number assigned to Harry Bounel, born in 1890. In his declaration (Exhibit 3) Hendershot states that he was thrown to the ground, handcuffed and threatened with arrest unless he gives FBI "consent" to search his computers and unless he gives the FBI the pass-code to his computers. Please, see in Exhibit 3 declaration by Albert Hendershot, "consent" to search computers by Albert Hendershot given to FBI and receipt for computer taken by the FBI from researcher Albert Hendershot. This information is important, as it confirms information providing in the complaint, showing Defendant Obama using fabricated IDs and a Social Security number which was assigned to another individual. It also shows a pattern of Obama using the means of the U.S. government, among them FBI, to harass, intimidate, bully the whistleblowers, deprive them of their constitutional rights under color of authority with the purpose of covering up Obama's use of a stolen Social security number and fabricated IDs.

All of this supplemental evidence shows that Superior Court Judge Charles

Marginis erred in dismissing Taitz v Obama et al and erred in denying motion by

Taitz to compel the custodian of record, Occidental college, to produce redacted

college application and registration for Obama and in awarding the attorneys fees to the custodian of records.

(Photo of envelope stamped "CARDED ON CONDITION THAT THE HOLDER REMAINS IN \_\_\_\_ NO LONGER THAN \_\_\_\_ ETAY)

00:05 NARRATOR: Here is the photo of the eighteen year old, attached to his Occidental college application.

00:11 NARRATOR: Nickname "Oxey", it's a small national ranked liberal arts college wedged between downtown Los Angeles and Pasadena.

00:17 JIM TRANQUADA (Occidental College, Dir of Comm): Occidental has been a movie set since 1919.

00:21 NARRATOR: It might look a bit familiar.

(Brief movie clips, followed by view of fountain)

00:25 JIM TRANQUADA: The fountain was built just before Senator Obama arrived on campus. It had a very brief role in Star Trek 3, for Spock's funeral.

(Brief movie scenes, followed by view of building entrance, then interior)

00:36 NARRATOR: This is Haines Hall annex, currently under renovation.

01:58 NARRATOR: While attending a fundraiser in San Francisco, Obama mentioned a three-week trip he took with Hamid to Pakistan and India, which included a visit with Chandoo's family. He was 20 years old at

the time.

02:08 OBAMA: Foreign policy is the area where I am most confident that I know more and understand the world better than Senator Clinton or Senator McCain. I knew what Sunni and Shia was before I joined the Senate Foreign Relations Committee."

02:24 ADAM GOLDMAN: If this three-week trip to Pakistan had left such an impression on him, why didn't he write about it in this book?

02:30 NARRATOR: Adam Goldman writes for the Associated Press, in the New York Bureau.

02:33 ADAM GOLDMAN: The campaign confirmed about Margo Mifflin, who dated Chandoo, she confirmed the story, and he traveled with Wahid. The campaign hasn't talked too much about it, and Wahid '"wouldn't return our phone calls, and Chandoo declined to discuss it as well.

02:47 NARRATOR: The campaign did not elaborate on our questions but referred us to an April Newsweek interview in which Obama said "Part of the most memorable portion was seeing what was essentially a feudal life. You had peasants who were still functioning as indentured servants."

03:00 ADAM GOLDMAN: Clearly it left an impression on him.

03:03 NARRATOR: Soon after that trip Obama transferred to Columbia.

(TV banner "Dreams From My Father" read by Barack Obama)

03:06 OBAMA: I figured that if there weren't any more black students at Columbia than there were ato Oxey, I'd at least be in part of a true city, with black neighborhoods in close proximity.

03:15 NARRATOR: New York City, 1981. The city was a mess. At Columbia, Obama did not live in campus housing. He has shared few specific details of where he lived.

03:25 VIDEO OF OBAMA WITH MICROPHONE (screen shows date New York Sept 27, 2007): Used to hang out in Washington Square Park! I know a little something about Greenwich Village. I was about to say I know some ...(thumps mic)...I was about to say I know some of the bars around here, but I think my communications director was trying to cut that off.

03:44 NARRATOR: A campaign spokesman sent this email to Fox News stating that "We actually only have one actual address, othewise only streets or neighborhoods." Like many students, Obama moved around. Last October the same spokesman told the New York Times that Barack doesn't remember the names of a lot of people in his life.

04:02 NARRATOR: We're at 109th Street near Amsterdam, in New York
City's upper west side. In the early 1980's this was a very rough part
of town. Barack Obama vividly writes about one of his first nights in
New York City, saying he slept out in an alleyway that evening, only to
wake up in the morning with a white hen picking at garbage nearby. And
a homeless man washing himself in a fire hydrant.

04:24 MIKE SHEEHAN: The detectives up there called it 'Murder City'.

04:26 NARRATOR: Before he was a reporter for Fox 5 News, was a detective for the NYPD's North Homicide.

04:33 MIKE SHEEHAN: Dominican drug gangs had moved into that neighborhood and basically took the place over. There were killings every single night. There were chickens all over the place. I'm not making that up.

04:43 NARRATOR: Obama wrote that he moved to another address around 1982.

04:46 OBAMA: I was living in New York at the time, on 94th between 2nd and 1st. Part of that unnamed and shifting border between Harlem and East Manhattan.

04:54 NARRATOR: And Obama made a personal commitment while living in this 6 floor walkup building. "I stopped getting high. I ran three miles a day and fasted on Sundays." Despite his healthy regimen, Obama lived with the hard-partying roommate whom he had met in Los Angeles.

05:10 ADAM GOLDMAN: He was visiting Chandoo, at Oxey. He met Obama at a New Year's Eve party before Obama transferred to Columbia, I believe in August of 1981. They exchanged numbers. Obama looked him up when he got to New York City.

05:25 NARRATOR: Obama called him Sadik in his book, and described him as a short, well-built Pakistani who overstayed his tourist visa and now made a living in New York's high-turnover illegal immigrant workforce waiting tables.

05:37 ADAM GOLDMAN: And I managed to track him down. Obama's descriptions of Sadik in the books, Sadik confirms them as accurate.

05:43 NARRATOR: Adam Goldman broke the story May 15th. Fox News has confirmed that Sadik's real name is Sulhow Howsadiki.

05:50 ADAM GOLDMAN: That's his email.

05:51 NARRATOR: Howsadiki declined our producer's interview request by phone, in person, and by email.

05:56 ADAM GOLDMAN: He was dabbling in cocaine at the time he was living with Obama. Sadiki maintains that they did not do drugs together.

06:05 NARRATOR: It was here in 1982 that Obama received a life changing phone call.

06:10 OBAMA: This is your aunt Jane in Nairobi. Listen Barry, your father is dead. He's killed in a car accident.

#### DECLARATION OF ORLY TAITZ

I am an appellant in Taitz v Obama, Fenstein, Emken in front of the Fourth District Court of Appeal, State of California Case G047746. I have personal knowledge of the facts described below and attest under the penalty of perjury of the following:

- 1. On 06.19.2013 I participated in a rally in front of the U.S. Capitol.
- 2 At the rally I met a whistleblower, who is an employee of the Higher Education Services Corporation in Albany New York. (Hereinafter HESC)
- 3. The whistleblower advised me that she is seeking to provide to a judge evidence of fraud.
- 4 The whistleblower stated that she personally reviewed financial aid records of Mr. Barack Obama. She reviewed the financial aid microfilm, where it stated that Mr. Obama received financial aid as a foreign student, citizen of Indonesia.

- Whistleblower provided me and wrote in her own handwriting her first and last name, her home and cell phone numbers and her work and personal e-mail addresses.
- 9. Whistleblower stated that she is concerned about retaliation by Mr. Obama and Obama regime.
- 10. I did my due diligence and verified that indeed aforementioned whistleblower is employed by the Higher Education Services Corporation.
- I verified that Mr. Obama indeed transferred from the Occidental college to the Columbia.
   University in New York, therefore his financial aid would be handled by Albany, New York office.
- 12. Due to the fact that the whistleblower is concerned of retaliation, I am asking the court to allow to submit her identification information under seal and any testimony, if needed by the court, to be done in camera.

#### DECLARATION OF ALBERT HENDERSHOT

I, Albert Hendershot, am over 18 years old, I am a debt collector and investigator residing in Birmingham Alabama area. I have personal knowledge of facts listed below and I am willing and able to testify in the court of law in regards to the following facts:

- I am working with attorney Orly Taitz on the issue of a Connecticut Social security number xxxxx-4425, which Barack Obama listed on his 2009 tax return posted on WhiteHouse.gov. Originally Mr. Obama did not flatten the PDF file, the full SSN number became available to the public and it subsequently failed both E-Verify and SSNVS.
- I am greatly concerned with the fact that we have an individual in the White House with an invalid Social Security number which was not issued to him.
- 3. I embarked on research and found that the number xxx-xx-4425 was assigned to Harry Bounel.
- On February 4 2013 I signed and notarized an affidavit relating to my findings and I mailed it Attorney Taitz. Exhibit 1 is my true and correct affidavit.
- In my affidavit I stated that I performed a search in Merlin Information Systems database http/www.acxiom.com/identity-solutions, which is routinely used by debt collectors.
- I found that in the above databases Barack Obama and Harry Bounel are listed as holders of the same Social Security number xxx-xx-4425 and listed at the same address at 5046 s. Greenwood Ave. Chicago, Illinois
- Aforementioned record shows Michelle Obama being a relative of both Harry Bounel and Barack Obama
- 8. Attorney Taitz made this affidavit public and submitted it to court.
- On April 10, 2013 I was visited by FBI agenst who asked me for my computer and the password for my computer.
- I asked if they had a warrant, they said that they did not have a warrant and I told them to go away and get off my property.
- 11. I called the local FBI office in Birmingham AL and asked if there is a warrant for any of my property and if they are aware of FBI employees going to my house. FBI employee answering the phone did not have any such information.
- 12. Shortly thereafter the same FBI agents came to my house with several police officers. I was thrown to the ground and handcuffed. FBI officer by name Jacob U. Blair (see his signature on Exhibit 2) gave me his FBI ID. A supervisor got out of his car and told me "we can do it the easy way or the hard way". He proceeded saying that if I voluntarily give my computers and the pass-code to my computers, I will not be arrested.

13. As I was handcuffed and being concerned of being hauled to jail, under duress I signed a "consent" to search my computer and FBI officers gave me a receipt. (Exhibit 2 Consent to search computers and receipt by the FBI). Two weeks later FBI returned my computer.
