Jurisdiction

This court has jurisdiction, as the defendants Loretta Fuddy, in her official capacity as the Director of Health, State of HI Department of Health (Hereinafter "Fuddy", and Alvin T. Onaka, Regisrtrar of the Department of Health (hereinafter "Onaka") are located at 1250 Punchbowl street within Jurisdiction the First Circuit Court of the State of HI.

Governing Statute

Unified Information Practices Act, as codified in statute 92F

Parties

Factual allegations

1. Defendant Fuddy in her official capacity as Director of Health is a custodian of the original birth records of individuals born in HI, or individuals born abroad, who received Hawaiian birth certificates pursuant to statute 338-17, as well as Late Birth Records, created later in life under statute 338-6 when the original birth records are not available.
2. Defendant, Dr. Alvin T. Onaka, in his official capacity as the registrar of the Department of Health is the state of Hawaii official responsible for the authentication of the original records and the certified copies of the original records.

3. Under Article 2, section one of the Constitution of the United States President of the United States has to be the "natural born citizen" of the United States of America.
4. Article 2 section one is the only law/statute governing the eligibility of the President of the United States. U. S. Constitution is the Supreme law of the land, which supersedes any state statutes. No state statute, no state claim of privacy can supersede the requirement of the of the US Constitution for the President to be "Natural born" or de facto invalidate the Constitutional requirement by refusing to provide access and right for inspection of the admissible competent evidence of Natural Born status.
5. Fourteenth amendment of the Constitution does not provide definition of the "Natural Born citizen" as it relates only to the requirements of the citizenships and not "Natural Born Citizen" for the purpose of the qualification for the presidency of the United States.
6. "Natural Born Citizen" is different from "Native Born Citizen" and "Citizen at birth"
7. Citizen at birth provides one citizenship based on law or statute, regardless, whether born in the United States or not.
8. Native born Citizen is one born in the country, but might allow for split allegiance to other sovereignties.
9. "Natural Born Citizen" is the form of citizenship with the highest requirements of allegiance, based on "Jus Solis" and "Jus Sanquinis", born in the country with allegiance by blood (inherited from both parents".
10. Only one person at a time is required to possess this highest form of allegiance and citizenship- President of the United States. Such highest form of allegiance was sought by the framers of the United States Constitution in order to assure an undivided allegiance of the President of the United States of America and the Commander in Chief.
11. Barack Huissein Obama, currently occupying the position of the President of the United States, claims to be born in the state of Hawaii and claims the original typewritten long form birth certificate, created in 1961, is on file and in custody of the Defendants.
12. For nearly three years Mr. Obama refused to release his original long form birth certificate with the name of the doctor, hospital, registrar and other pertinent information.
13. Multiple individuals, including members of the US military demanded to see the long form birth certificate to make sure, that Mr. Obama is indeed qualified for the position of the P{resident of the United States and Commander in Chief.
14. Highly decorated U.S. Army officer, Bronze star recipient, flight surgeon LT. Col. Terrence Lakin was court martialled and spent six month in Fort Leavenworth military prison for demanding to see verification of legitimacy of Mr. Obama, as the president of the United States. In spite of thousands of requests for Mr. Obama to provide his long form birth certificate and spare a decorated officer, he refused to do so and in December of 2010 Lt. Col. Lakin was sent to prison.
15. Plaintiff herein is an attorney who represents other clients, questioning Mr. Obama's legitimacy to presidency, among the former UN ambassador Dr. Alan Keyes, 10 State Representatives from around the Nation and over 200 members of the military, going up in rank to Major General. She was named by the media "Queen of the Birthers", leader of the decident movement, questioning Barack Hussein Obama's legitimacy to the US Presidency.
16. Plaintiff and her clients were viciously attacked, defamed and persecuted for demanding to see the original record, which is the basis of Mr. Obama's eligibility to the U.S. Presidency.

17. On May 2, 2011 Taitz was scheduled to appear in oral argument in the Ninth Circuit Court of Appeals, in Barnett, Keyes et al v Obama 10-55084, seeking access and inspection of Mr. Obama's original 1961 long form birth certificate, kept on file in care of the defendants.

18. On April 27, 2011, only a few days before the scheduled oral argument in the Ninth Circuit court of Appeals, Mr. Obama held a public press conference, where he disclosed, what he claimed to be the certified copy of the original Birth Certificate. At the same press conference Mr. Obama attacked individuals, seeking verification of his records, calling them "side show, carnival barkers" and stating, that we have more important things to do. This appearance was certain to influence the three judge panel of Hon. Berzon, Hon. Pregerson and Hon. Fisher of the Ninth Circuit Court of Appeals, getting ready to hear the oral argument in Barnett, Keyes v Obama and was calculated to send the message, that the original long form birth certificate was disclosed to the public and the whole issue is moot. This cheap performance by Mr. Obama was also calculated to create a mass hysteria of further persecutions and harassment of the Plaintiff and her clients.

19. Shortly after Mr. Obama disclosed an alleged certified copy of his birth certificate and posted it on the WhiteHouse.gov official web site, for the whole world to see, Taitz started getting multiple affidavits of experts, attesting to the fact, that the document disclosed by Mr. Obama to the world and posted on line is a computer generate forgery.

20. Mr. Felicito Papa, an expert in Adobe software provided an affidavit and exhibits, showing that the document in question was computer generated and shows different layers of computer images, that were used and compiled together in order to create this "birth certificate". Exhibit 1.

20. Mr. Paul Irey, an expert in typesetting with over 50 years of experience, provided an affidavit, showing that the letters and numbers in the document came from multiple different typesetting, which is a clear evidence of forgery. Exhibit 2

21. Mr. Douglas Vogt, a 40 year expert in scanners and printers provided evidence of a mixture of different inks, kerning, gray scale mixed with color, mixture of ink writing and computer generated graphics, showing the document to be forged. Exhibit 3.

22. Alleged certified copy of Obama's birth certificate showed serial number 10641 and date of issuance 08.08.1961, which was completely out of order with previously made public certifications of Susan and Gretchen Nordyke, bearing serial numbers 10638 and 10639, even though issued on 08.11.1961, three days earlier.

23. Individuals, who do not possess valid birth certificates cannot obtain valid social security numbers. From February 2011 until now Taitz is prosecuting a 5 USC 552 Freedom of Information case Taitz v Astrue 11-402 RCL, USDC District of Columbia, where Taitz provided Obama's Selective service certificate, showing him using Connecticut Social Security number 042-68-4425 (Exhibit 4) and Social Security Verification Systems letter, showing that this number was never assigned to Obama. This provides further evidence, that Barack Obama does not have a valid birth certificate and does not have a valid social security number assigned to him.

24. Similarly, Taitz obtained verification from the Student Clearing house, showing Obama attending Columbia University only for 9 months, which contradicts Obama's public statements, where he claims to attend Columbia for two years. All of this information shows a pattern of fraud and lack of valid vital records.

25. On May 4 of 2011, Taitz sent certified mail requests to defendant Loretta Fuddy, director of Health and defendant Onaka, requesting inspection of Obama's 1961 original birth certificate under Unified Information Practices act of HI, codified as 92F,

26. Taitz received a response from Alvin T. Onaka, dated May 19, 2011, whereby Onaka stated, that he is responding on behalf of Fuddy and his own behalf and refused to allow inspection, citing privacy concerns and state statute HRS-§338-18

27. Taitz requested an administrative appeal and reconsideration, due to the fact, that Obama already waived any claims of privacy in regards to his long form birth certificate by disclosing it to the public and posting it on the official website WhiteHouse.gov

28. From the beginning of June, for a period of three month, there was no response to the request for the administrative appeal, which is tantamount to a denial of the request for the appeal.

28. Knowing, that the certificate of live birth posted on WhiteHouse.govTaitz is a forgery according to experts, Taitz looked for a possible source of the serial number 10641 used on that birth certificate.

29. A long time close friend of Obama is a known domestic terrorist William Ayers, leader of the terrorist organization "Weathermen", which was responsible for some 110 bombings around the country in the early 70s, among them bombings of the Pentagon, Capitol, New York city police headquarters and military barracks.

30 Ayers and his wife Bernardine Dorn were on the run for ten years and needed forged and fraudulently obtained vital records.

31. In his book Fugitive Days Ayers described his methods of obtaining fraudulent vital records, among them search of the graves of the deceased infants and use of their birth certificate numbers.

32. On August 4, 1961, same day, as the alleged date of birth of Obama, an infant by name Virginia Sunahara was born at the Wahiana hospital in Honolulu.

Due to health problems she was immediately transferred to the Kapiolani hospital, where she died next day, on August 5, 1961. Hi state archives show her birth and death listed among ones bor n and one deceased in 1961, but repeated request for her birth certificate yielded a response, that there is no birth certificate on file. While it could be understandable for the Health Department to respond, that the record is not available due to privacy, it is suspicious, that the Health department responded to the petitioners, that it does not exist.

33. On June 4, 2011 Taitz requested from defendant Fuddy a certified copy of Sunahara's birth certificate, but Fuddy did not respond.

34. As of now defendants did not allow examination of the original long form birth certificate for either Obama or Sunahara.

Complaint for petition for the Writ of Mandamus, request to allow inspection

1. Plaintiff incorporates by reference all of previous paragraphs as if fully plea herein.
2. Hawaii Unified Information Practices act UIPA, as codified under 92F allows the public at large inspection of records in custody of the state agencies, unless such records are protected by local privacy codes.

3. Obama has already waived any claims of privacy in relation to the original long form birth certificate, as he personally disclosed the document and posted it on the official White house internet site WhiteHouse.gov easily accessible by any US or foreign citizen.
4. Additionally Obama expressly waived any privacy concerns by and through his private attorney, Judith Corley, who personally signed a waiver of any privacy concerns in her letter to defendant Fuddy. "We understand that the Department of Health has adopted this policy for sound administrative reasons. However, we are writing to request a waiver of the Department of Health's policy, so that my client can obtain two certified copies on his original, "long form" birth certificate. **Waiver of the Department policy in this instance would allow my client to make a certified copy of his original birth certificate publicly available** and would also relieve the burden currently being placed on the Department of Health by the numerous inquiries it receives from the media and others relating to my client's birth record." Id Exhibit 6 Letter from Judith Corley, private attorney for Obama, requesting waiver of privacy for purposes of disclosure of Obama's original birth certificate. Emphasis added. Defendant Fuddy agreed to such public disclosure and wrote in her April 25th letter to Obama: "We hope that issuing you these copies of your original Certificate of Live Birth will end the numerous inquiries received by the Hawaii Department of Health to produce this document...Enclosed please find two certified copies of your Certificate of Live birth. I have witnessed the copying of the certificate and attest to the authenticity of these copies" . As such, Fuddy acknowledged her understanding, that the document on question will be made public and the subject of this document and his attorney consented to public disclosure. Privacy is no longer at issue, however computer generated forgery is at issue and the public at large is entitled to know, whether Fuddy is telling the truth and whether indeed the document on file is the same forgery as the one posted on the WhiteHouse.gov. If the document on file is the same forgery, immediate criminal investigation, as well as congressional hearing on constitutional eligibility of Mr. Obama will need to commence.

5. § 92F-2. states the following:

Purposes; rules of construction

In a democracy, the people are vested with the ultimate decision-making power. Government agencies exist to aid the people in the formation and conduct of public policy. Opening up the government processes to public scrutiny and participation is the only viable and reasonable method of protecting the public's interest. Therefore the legislature declares that it is the policy of this State that the formation and conduct of public policy--the discussions, deliberations, decisions, and action of government agencies--shall be conducted as openly as possible.

The policy of conducting government business as openly as possible must be tempered by a recognition of the right of the people to privacy, as embodied in section 6 and section 7 of Article I of the Constitution of the State of Hawaii.

This chapter shall be applied and construed to promote its underlying purposes and policies, which are to:

- (1) Promote the public interest in disclosure;
- (2) Provide for accurate, relevant, timely, and complete government records;
- (3) Enhance governmental accountability through a general policy of access to government records;

(4) Make government accountable to individuals in the collection, use, and dissemination of information relating to them; and

(5) Balance the individual privacy interest and the public access interest, allowing access unless it would constitute a clearly unwarranted invasion of personal privacy.

The intent of the legislature is to provide transparency and public access to information, while balancing it with concerns of privacy of the individuals, who wish their information to remain private. As Obama has expressly indicate through his personal attorney Judith Corley and through his release of the document in question to the public, he does not wish the document to remain private. As such there is no justification for defendant's refusal to allow inspection of the document in question.

6. While prior to April 27, 2011 release of the document in question, defendants were justified in protecting privacy of the document in question, citing HRS §338-18, as confirmed in Justice v Fuddy, after April 27, 2011 HRS § 338-18 can no longer be used as the justification for refusal.

Wherefore Plaintiff respectfully seeks a Writ of Mandamus, advising the defendants, that:

1 Person of interest, whose long form birth certificate is sought has waived any claims of privacy by making a public disclosure of the document in question during his press conference on April 27, 2011.

2. After April 27, 2011 §338-18 no longer applies to the long form birth certificate sought and Defendants erred in refusing to allow inspection based on above statute.

3. Defendants are obligated to allow Plaintiff inspection of the long form birth certificate sought under Unified Information Practices Act chapter 92f of Hawaii Revised statutes.

4 Defendants are liable to the plaintiff for all costs and fees associated with this action.

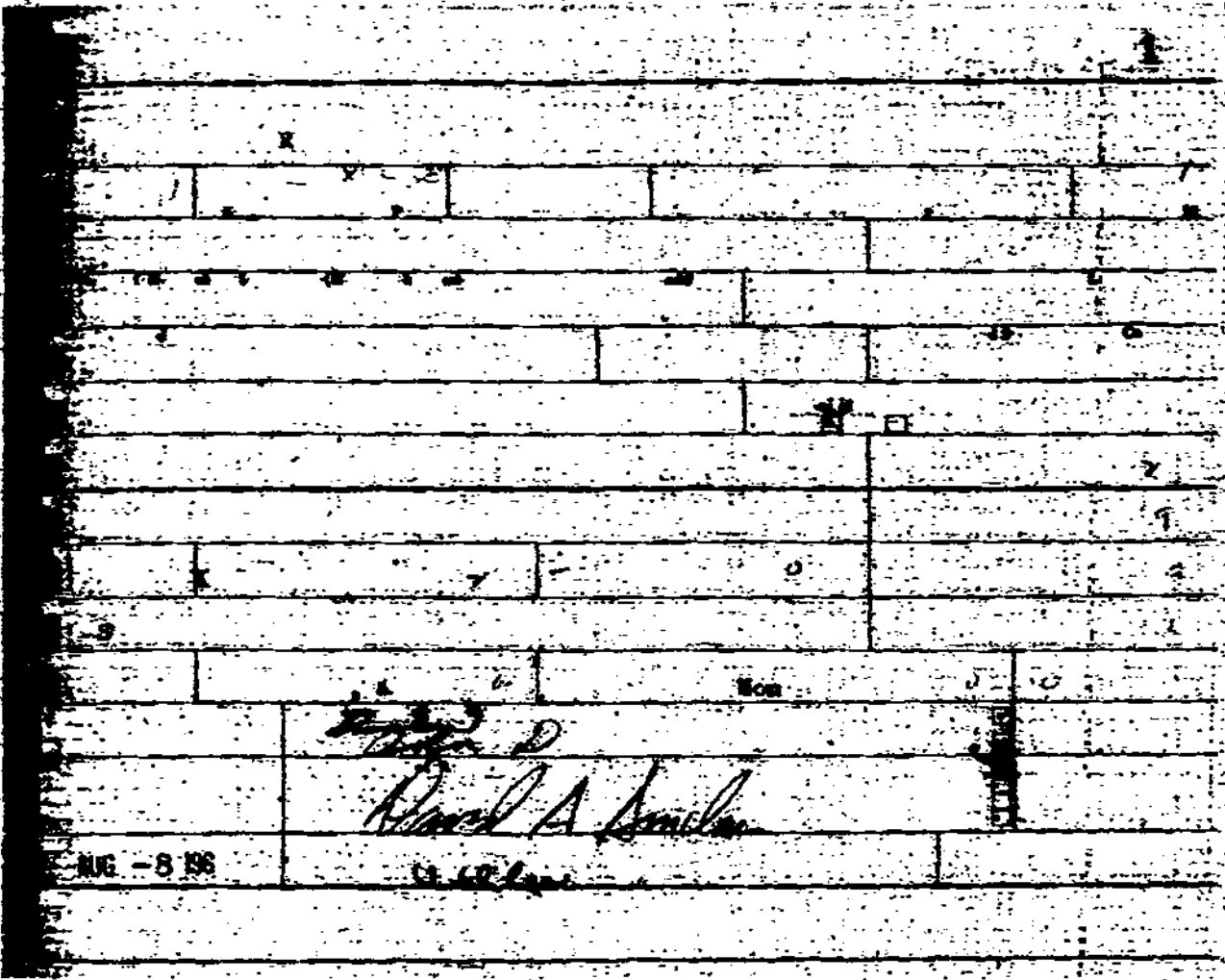

I, Douglas B. Vogt, am over 18 years old, do not suffer from any mental impairment, have personal knowledge in the following and attest under penalty of perjury that I have knowledge and expertise in documents, imaging, scanners and document imaging programs. Based on my knowledge and expertise the following is true and correct

My Credentials

I have a unique background for analyzing this document. I owned a typesetting company for 11 years so I know type and form design very well. I currently own Archive Index Systems since 1993, which sells all types of document scanners worldwide and also developed document imaging software (TheRepository). I know how the scanners work. I have also sold other document imaging programs, such as Laser Fiche, Liberty and Alchemy. I have sold and installed document imaging systems in city and county governments, so I know their procedures with imaging systems and everything about the design of such programs. This will be important in understanding what has happened with Obama's Certificate of Live Birth.

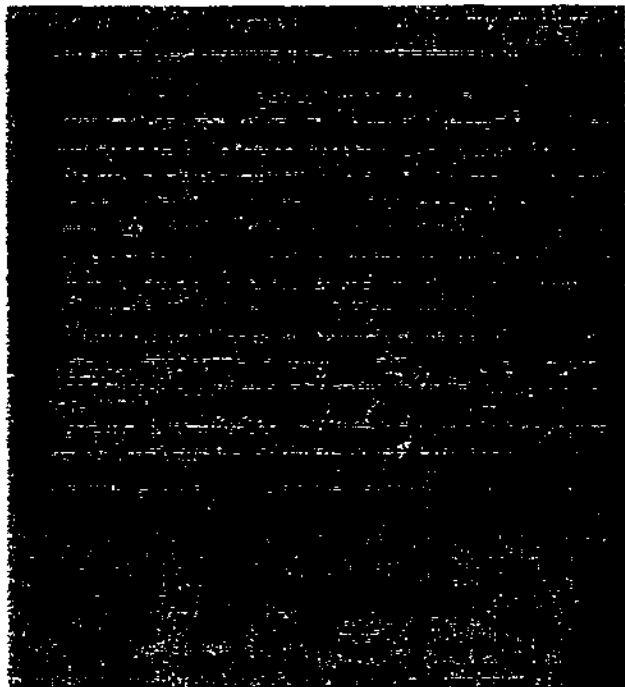


Figure 1. Tiff image of the Obama's Certificate of Live Birth dated August 8, 1961, presented on TV 4/27/2011.

What I Discovered about Obama's Certificate of Live Birth and why it is a Forgery.

What the Obama administration released is a PDF image that they are trying to pass off as a Certificate Live Birth Long Form printed on green security paper by the County Health Department. The form is a created forgery for the following reasons.

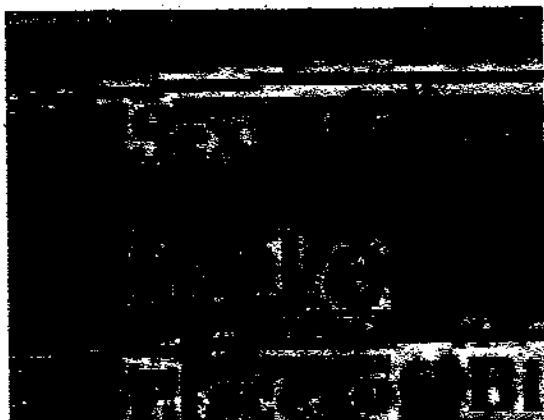


Figure 3. Line 2 of the form. Baseline differences.

1. **Curved and non-curved type.** The image we are looking at was scanned in grayscale and some part in binary which cannot be on the same image. The reason I know this is because of the shadowing along the gutter (left-hand side). It also means that the county employees who did the original scanning of all the forms, did not take the individual pages out of the post binders. The result is that all the pages in that book display a parallax distorted image of the lines and type. They curve and drop down to the left. If you look at line 2 (Figure 3) on the form that says *Sex* you will notice the letters drop down one pixel but the typed word *Male* does not. Also notice the line just below *Male* drops down 3 pixels.

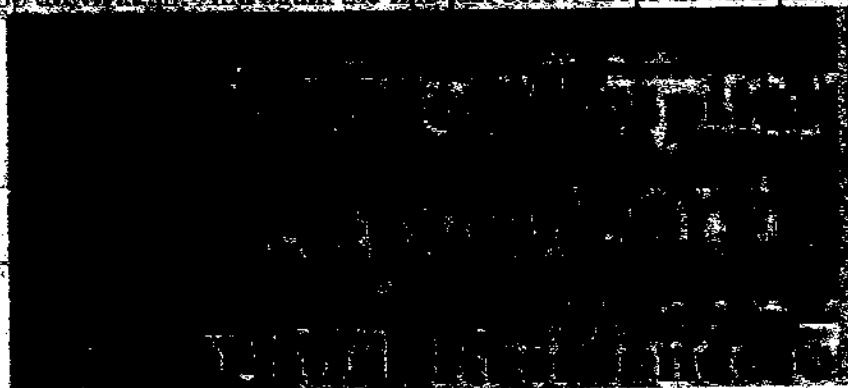


Figure 4. Line 6c at 600%. The typewritten name of the hospital does not drop down 2 pixels.

The second incident of this parallax problem is seen in line 6c *Name of Hospital or Institution* (Figure 4). The word *Name* drops down 2 pixels, but the typed hospital name, *Kapiolani*, does not drop down at all. And again the line just below drops down 2 pixels, but not the name *Kapiolani*.

The conclusion you must come to is that the typed in form was superimposed over an existing original Certificate of Live Birth form from the county. In fact, since I found some of the form headings scanned in as binary and grayscale, the form itself is a composite but the person who created it did not flattened the image of the blank form and save it as one file before they started placing the typewriter text on the composite form. The individual(s) who perpetrated this forgery could not evidently find a blank form in the clerks imaging database, so they were forced to clean up existing forms and overlay the typewriter type we see here. The forger was also looking for certificates with the correct stamped dates and that is why I think they used more than one original form. At first I wondered why the forger didn't just typeset the entire form from scratch and overlay the type and not have to worry about the parallax problem. Then I remembered that in the early

1960s there was no phototypesetting and this form was set in hot metal from a linotype machine. The type design is Times Roman but they could never replicate the exact design. They were stuck having to use existing forms that were scanned in using binary and grayscale.

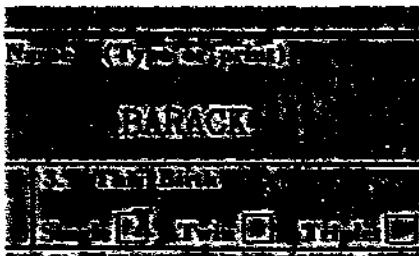


Figure 5. Obama's form

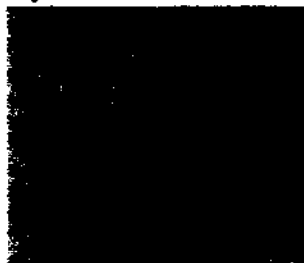


Figure 6. Grayscale

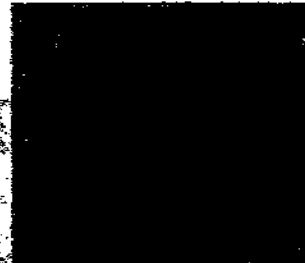


Figure 7. Color image.

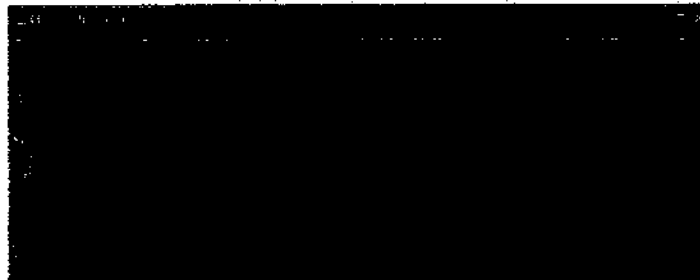


Figure 9. An enlarged version of Figure 6 showing grayscale type.

2. There is a white haloing around all the type on the form. Figure 5 is an example of this. This effect should not appear on a scanned grayscale image. Figure 6 is a grayscale image scanned in at 240 dpi. You will notice that there is no haloing effect around the type and also the security pattern is seen through the type. Figure 7 is a color image where you can clearly see the security green color through the type and no haloing. Figure 8 shows a Black and White (binary) image of the same type. The important thing to remember is that you cannot have grayscale and binary on the same scan unless the image is a composite. That means that different components of the whole image are made up of smaller parts. Figure 9 is an enlarged version of Figure 6 showing what grayscale letters should look like compared to binary.

3. The Obama Certificate is loaded with both binary and grayscale letters which is just another smoking gun that this form is a forgery. It appears the lines and some of the boxes were scanned using grayscale, but only some of the form headings were grayscale and sometimes it is only some letters. Figure 10 and Figure 4 give one example. You will notice that the *H* and *al* in Hospital, *I* in Institution, (*I*f and again the *h* and *I* in hospital were grayscale images, but the rest of the line is binary. The typewriter line below was scanned in as a binary image. I can also tell you for certainty that the form type was scanned in at a lower resolution (≤ 200 dpi): This is because of the size of the pixels on the letters were such that the openings on the *a* and *s* on the first line are not visible and filled in.



Figure 10. showing a mixture of grayscale and binary type on the same line.

Another example is found in form box 1a, his name *BARACK*. For some reason the "R" is a grayscale image and the rest is binary (Figure 11). That means the "R" was originally on the form and the rest was not until it was added.

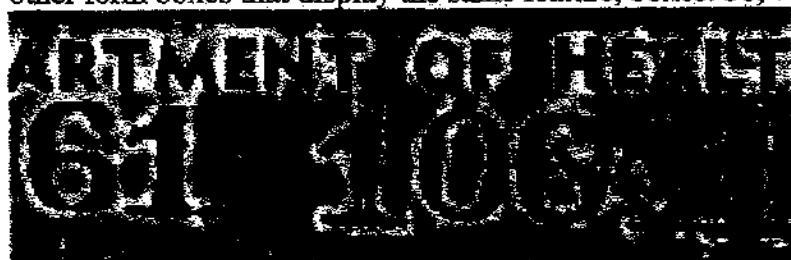


Figure 12. The last "1" is grayscale, but the rest are binary.

Another example is the Certificate number itself (Figure 12). The last "1" on the form is a grayscale image but the rest of the numbers are not. This is just another example of a cut and past job. It also means we do not know what the real Certificate number is if there even is one. There are other form boxes that display the same feature, boxes: 5b, 7e, 11, 13, 16, 18a.

4. The Sequential Number is a fraud. I would like you to refer back to Figures 1 and 2. You will notice that Barack Obama was supposed to have been born on Friday at 7:24 p.m. August 4, 1961 and the local registrar accepted it on Tuesday August 8, 1961 and hand stamped the Certificate number "61 10641." Then notice that the other Certificate of Susan E. Nordyke was born on Saturday at 2:12 p.m. August 5, 1961 and another registrar date stamped it on August 11, but her Certificate number is "61 10637." Keep in mind there would be only one bates stamp machine in the office so the numbers would all be unique. There cannot be any duplicates so every Certificate has a unique serial number. Obama's Certificate would have most likely been mailed on the following Monday, the 7th and received by the Clerk Tuesday the 8th. Susan Nordyke's Certificate looks like it was mailed sometime earlier that week and not accepted until the 11th but she has a Certificate 4 numbers less than Obama's. It is impossible to have Obama's Certificate number to be four numbers higher than a Certificate that came in 3 days later.

The facts I have shown you in #3 and 4, tell me several things about how this forgery was assembled. 1. Some person(s) in the Health Department, who had access to the document imaging program, search the database for someone close to the actual birth date of Obama and found someone near the 4th of August. They may have cross referenced the death database to find someone who had died and had a birth date close to Obama's. If you remember, the Federal Government wanted the States to cross reference the birth and death databases so the database would have that information. 2. The date stamps have two different colors and sizes (see #5 below) which indicates that both dates came from different Certificates. 3. More than one person is involved in the Hawaii Department of Health to assemble the different components that were used, do the database searches to find the right Certificates to create President Obama's fraudulent Certificate of Live Birth and finally sign the fraudulent certificate. I believe that after all the components were

assembled they were then given to a graphic artist to actually assemble the whole thing and create the finished forgery. In short this was a conspiracy to defraud the United States.

5. Two different colors and font sizes in Form box 22 and 20 Date Accepted by Reg. General.

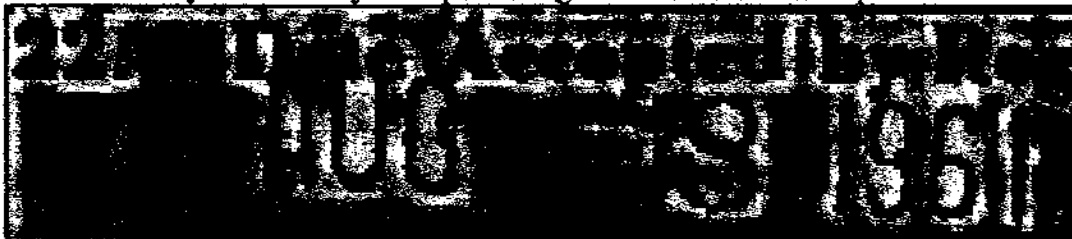


Figure 13. Two different colors, dark green and black.

What is very revealing about this box and date entry is there are two different colors on both lines. Both lines were scanned using binary mode, but I see two different colors (Figure 13). What I think this is showing us is that the person who put this fraud together was looking for a form that had the right date namely "August 8 19 1." As you can see the only things that are printed in dark green (R=71, G=92, B=73) are "Date A" and "AUG -8 6." The rest of the type is in black. This tells me that the forger was working in color mode. ~~Finally the Font size of the rubber stamp in box 22 is larger than the stamp used in box 20. This is unlikely because the same rubber stamp would have been used by the same registrar to stamp the dates in both places and sign the form in box 21. Since we have two size letters and numbers, that means these elements were taken from two separate forms that may have been years apart using different rubber stamps.~~

The same thing is found in form box 20 "Date Accepted by Local Reg." Figure 14 again shows that the date has two different colors. The "AUG -8 196" is in dark green (R=87, G=111, B=87) and the "1" is in black. Yet again, another irrefutable proof this form is a forgery. Form box 17a displays the same two color image in the word "None". The "Non" is in dark green.

6. Multiple layers in the PDF file from the White House. I am not the first one to find this fact and they deserve the credit for discovering it. What they discovered is that when you open up the PDF file in Adobe Illustrator and you turn on layers, you see a long list of nine different layers that correspond to different sections of the form, including the signatures on the form. I discovered using just my Adobe Acrobat 8 Standard that I could also see the different components disappear when I enlarged the image to just 400% and used the "hand" tool to quickly move around the image. When I moved the image fast, the various type components would disappear from the form but the lines stayed just as I had concluded.

A Rebuttal to the Discovery of the Multi Layers Found in the PDF File

The only rebuttal to the nine layers discovered in the PDF file released by the White House was a statement from a Canadian graphic artists from Quebec by the name of Jean-Claude Tremblay on April 29. It was reported by Fox News on their web site at

He tries to excuse the multi-layers as merely an artifact of an OCR (Optical Character Recognition) engine and then saved as a PDF. There are two major reason he is wrong and I know from his statement he knows nothing about OCR engines and how they work and their file structure. First of all the Obama PDF certificate was supposed to have come directly from the Health Departments office. As stated before, the records they have would have absolutely no reason to be OCRed and if they were asked to give the customer a PDF image it would be from their existing TIFF image stored in their document imaging program on the server. The program would have done no OCR processing at that time.

My qualifications on OCR programs are considerable. Our own document imaging program, TheRepository, has an OCR option from Expervision that is called TypeReader. We integrated TypeReader into our program but to do this we had to sign a non-disclosure statement with them and then we got their Took Kit and API. When an OCR program saves a file as a searchable PDF, the file contains three main files within it. The first file is an image file, usually a compressed Group4-TIFF. The second file is a ASCII text file and the last file is a matrix file that contains the X and Y coordinates of all the words in the document. The Starting point for the image file and the matrix file is usually the upper right-left hand corner of the image measured in pixels. The test file and matrix files would never be seen as separate layers and there is certainly no nine layers. The three files would be in a PDF "wrapper" and that's all. All OCR programs work on the same principle.

Conclusion

The Certificate of Live Birth Obama presented on television on Aril 27, 2011 is a forgery.

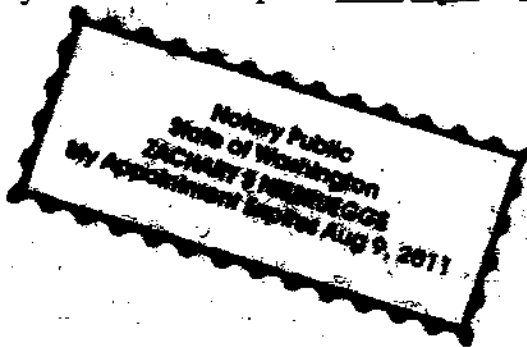

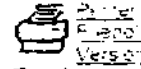

This is provided in response to your UIPA requests received by Health Director Loretta Fuddy and myself on May 9, 2011.

The State's public records law, the Uniform Information Practices Act (Modified) ("UIPA"), found at chapter 92F, Hawaii Revised Statutes ("HRS") requires that all government records be open to public inspection unless access is restricted or closed by law. Government records means information maintained by an agency in written, auditory, visual, electronic, or other physical form; see HRS §92F-3. The UIPA does not require an agency to provide access to government records that state law protects from disclosure, see HRS §92F-13 (4), nor does it require agencies to respond to all questions asked by the agency.

State law prohibits the department from disclosing any vital statistics records or information contained in such records unless the requestor has a direct and tangible interest in the record, or as otherwise allowed by statute or administrative rule. See HRS §338-18. Direct and tangible interest is determined by HRS §338-18(b).

For these reasons, your request received on May 9, 2011 is being denied in its entirety.

**REQUEST OF ACCESS TO RECORDS UNDER HAWAII UNIFORM INFORMATION
PRACTICES ACT OF 1975**

Dear Mr. Onaka,

For the last three years there were multiple requests made for release of Mr. Barack Hussein Obama's long form birth certificate.

In December of 2010 a highly Decorated U.S. military officer, bronze star recipient, Lt. Col Terry Lakin, was imprisoned, after he questioned, whether President Obama is legitimate for office in light of the fact, that he does not have a valid long form birth certificate. Lakin stated, that if he as an officer is required to show his birth certificate, so should the Commander-in-Chief. When LTC, Dr. Lakin stated that he would redeploy only after he could see a valid long form birth certificate of Obama, he was court-martialed, stripped of his military pension after 17 years of service and imprisoned. At the time, Mr. Obama ignored all

requests from hundreds of citizens, refused to show his long form birth certificate and LTC Lakin was sent to rot in Fort Leavenworth prison.

At the same time 9th Circuit court of Appeals allowed my case *Keyes, Barnett et al v Obama* to be presented at oral argument, which usually a sign that the court sees merit in the appeal. In this case, I, as an attorney for plaintiffs, demanded release of Mr. Obama's long form birth certificate, among a number of other documents. In an apparent preemptive strike, just two working days before the court hearing, Mr. Obama released, what he claimed to be a true and correct copy of his birth certificate. (Exhibit 1)

Analysis of what Mr. Obama released to the public, shows that it cannot possibly be a true and correct copy of the 1961 typewritten birth certificate, that Mr. Obama claims to have. While there some 70 areas in this computer image, indicative of the fact, that it is not a true and correct copy of the original birth certificate, most visible are following areas and easily demonstrated by comparing Mr. Obama's computer image with a birth certificate given to one, Susan Nordyke, born only a few hours after Mr. Obama, in the same hospital (Exhibit 2).

1. Original birth certificate was issued on white paper. Nordyke birth certificate is indeed on white paper, which is turning yellow due to aging process. Obama's birth certificate is on green safety paper, which was not used at the time.
2. Nordyke birth certificate has defined borders. Obama's birth certificate does not have borders.
3. Nordyke birth certificate contains an easily identifiable seal; Obama's birth certificate does not have a seal.
4. Nordyke birth certificate contains certification, that the above is a true and correct copy of the record, while Obama birth certificate states "...record or **ABSTRACT** of the record". (emphasis added). Since abstract of record can be absolutely anything, including old wives tales, literary, there is a need to inspect the original birth certificate in the health department.

Release of records typically involves balancing of the rights of the individual whose records are revealed against the rights of the public.




