## **Request for investigation**

Honorable Congressman Jordan,

Congratulations on becoming the Chair of the House Judiciary Committee. I am requesting your attention in review and investigation of the attached 155 pages file with evidence.

Firstly, as a licensed attorney, I believe that it is warranted for the Judiciary committee to investigate actions of President Biden and his top officials in allowing a spy balloon to traverse the United States and spy on multiple military installations. I believe there is a sufficient basis for the criminal referral and impeachment of President Biden and his top officials, involved in this matter for treason.

## 18 U.S. Code § 2381 - Treason

"Whoever, owing allegiance to the United States, levies war against them or adheres to their enemies, giving them aid and comfort within the United States or elsewhere, is guilty of treason and shall suffer death, or shall be imprisoned not less than five years and fined under this title but not less than \$10,000; and shall be incapable of holding any office under the United States."

Allowing a foreign spy balloon to spy on the US military installations without impediment represents "giving aid and comfort to the enemy." Further, if financial incentives were received, which were camouflaged as million dollar payments for Hunter Biden's "art" or Hunter Biden's "businesses", that may also call for prosecution for Bribery, Violation of Oath of Office and Public Corruption.
